Equity Taskforce	<p>Anna Hanlon presented on the President’s Task Force on Equity & Inclusion. The action plan for the college is tentative and is still being created. She shared some of the progress thus far.</p> <p>The task force was created in November 2020 with shared language and definitions created. In April 2021, visioning sessions were held on campus for the Educational Mater Plan and DEI plan. Key areas of focus aligned with the Educational Master Plan. In May 2021, the Task Force identified clusters and impact theories. Daisy Segovia is now managing the process for the DEI framework and draft DEI plan. Six different goals have been identified and faculty members serving on the committee include Stephanie Wells, Kisha Champion Williamson, Dr. Rebecca Ogaz, and Dr. Rendell Drew. Goal five, culturally responsive curriculum, was the goal the group worked on regarding goals and action plans. Feedback is requested at the upcoming visioning sessions. This moth through mid-March the plan will be reviewed and revised based on HEDS survey and focus group results to align with the Educational Master Plan and DEI Plan. In March, the DEI plan will be vetted with constituents and the final plan will be adopted in April.</p> <p>Anna displayed the identified action plan areas of Task Force and shared information on Goal 5, provide culturally responsive curriculum. Create peer-review process for curriculum within departments and division (design syllabi process), culturally responsive curriculum in all academic disciplines (training on best practices), develop process for safe and welcoming classrooms to validate</p>
